- Holidays and vacation days are billed the same as Sundays.
- Minimum total charge (mileage, travel, and labor, does not include parts) per service day \$500.00.
- Bills are closed out and invoiced weekly, Sunday through Saturday. When the total billable amount owed is \$2500.00 or more then that balance must be paid before additional services will be provided.
- 1st service call Estimate provided, this document signed by an individual that can approve payments to contractors and emailed, estimate prepaid, service scheduled, original copy of this document presented to technician upon arrival. Balance owed to customer or CNC Productivity paid COD. 2nd and following service calls, 5 % discount for COD payment or net 30.
 - PO's must state acceptance of CNC Productivity Service Rates and Terms.

Lodging and meals (per diem) billed per person per day per local rates. Averages \$195.00 - \$225.00 per day. Travel expenses less than \$250.00 may be paid per the invoice terms. Travel expenses more than \$250.00 are due COD. Airfare and car rental are prepaid or customer makes arrangements.

Parts, equipment rental, additional CNC Productivity help or outside contractors billed as incurred plus 20% or paid directly by customer. Amounts over \$250.00 due COD.

Rates and Terms may change without notice. Estimates / quotes provided upon request.

The customer agrees to pay a service charge per month of 1-1/2% per month (18% annual percentage rate) on all past due balances. In the event of any action to collect any overdue balances owed by the customer, the customer agrees to pay any and all expenses and/or collection costs including, but not limited to, reasonable attorney fees, collection agency fees, court costs, disbursements, CNC Productivity administration, labor or travel time and cost, etc, whether or not a formal action, suit or proceeding has been commenced against the customer. CNC Productivity is a dba of the New York State corporation Fleig Services, Inc. Any disputes between the parties shall be governed by the laws of New York State. The parties agree that any action, suit or proceeding shall be brought in the courts situated in Monroe County, New York and the parties hereby consent to said venue and to the jurisdiction of said courts. This document must be updated annually with the customer to provide services.

The customer is is not currently in bankruptcy, filing for bankruptcy or otherwise incapable of paying.
